



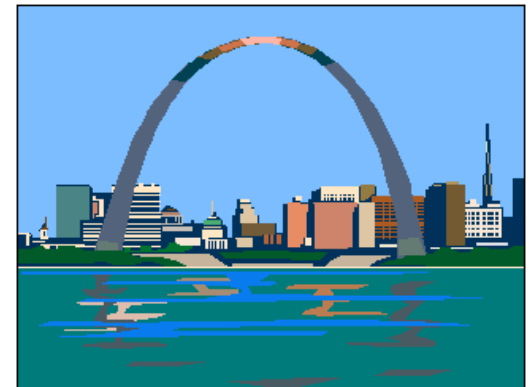

NTSP Website Metrics

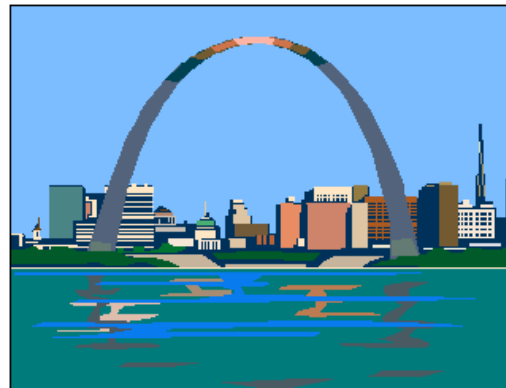
- We have introduced some new software that allows us to track the number of visits to our site, and to particular pages.
