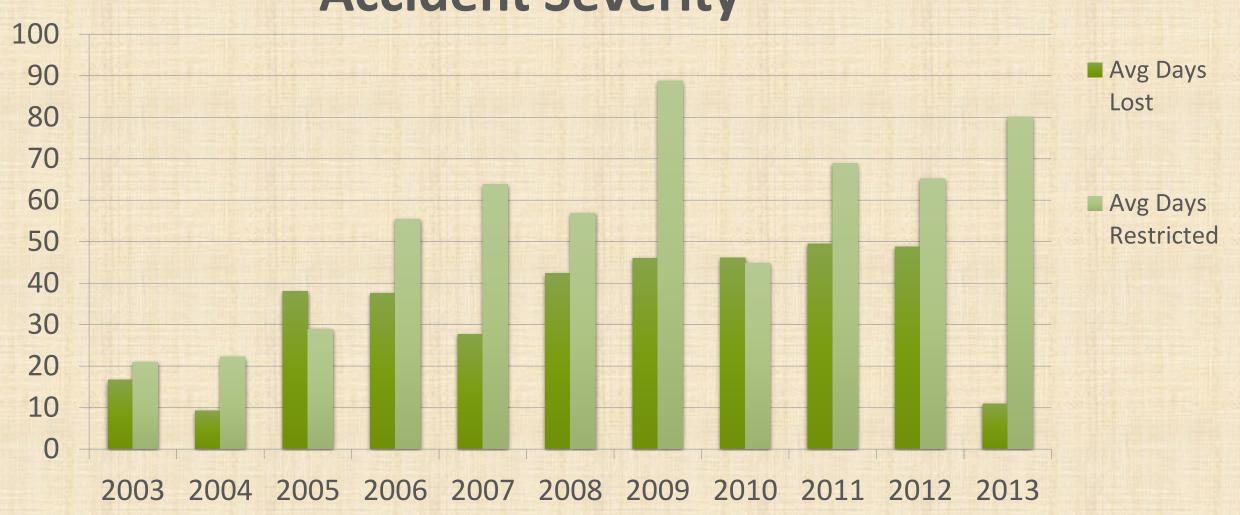






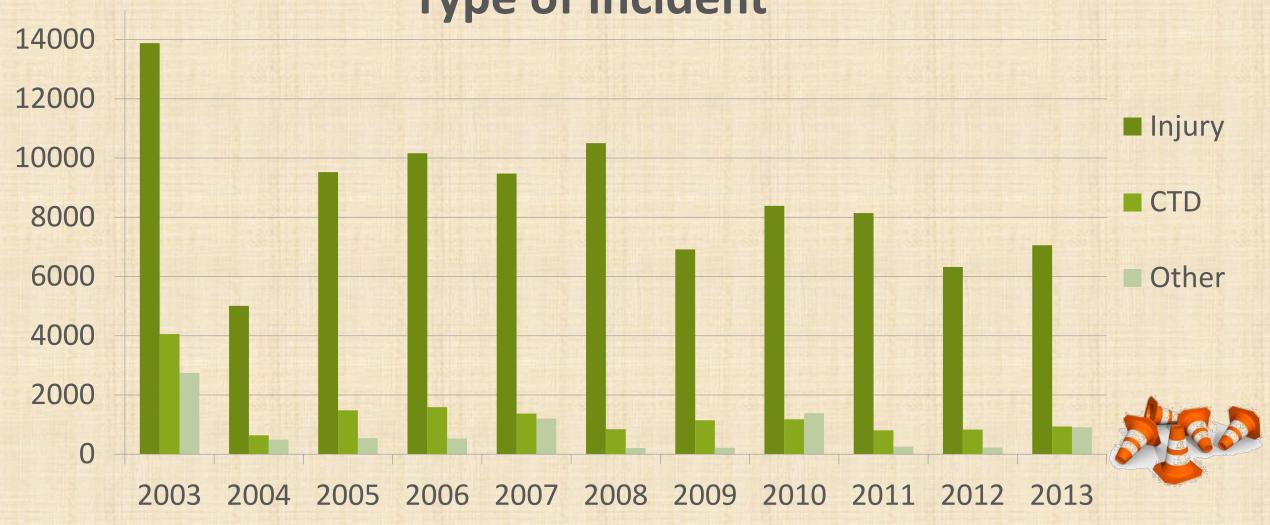














### EH&S Staff / 10,000 Employees - USA

### Frequency

#### **INJURY**

- Slip/Trip/Fall (5)
- Lifting (3)
- Struck by or Against
  an Object (1)

#### **Vehicle**

- PV Rear-End CV (2)
- Backing (2)
- CV Rear-End PV (1)
- Proceeding Straight (1)
- Struck Against (1)

### Severity

#### **INJURY**

- Lifting Exertion (5)
- Slip/Trip/Fall (2)
- CTD (1)

#### **Vehicle**

- CV Rear-End PV (3)
- PV Rear-End CV (2)

### ERGONOMIC SURVEY — EXERCISE BALLS 2014 EHSCP

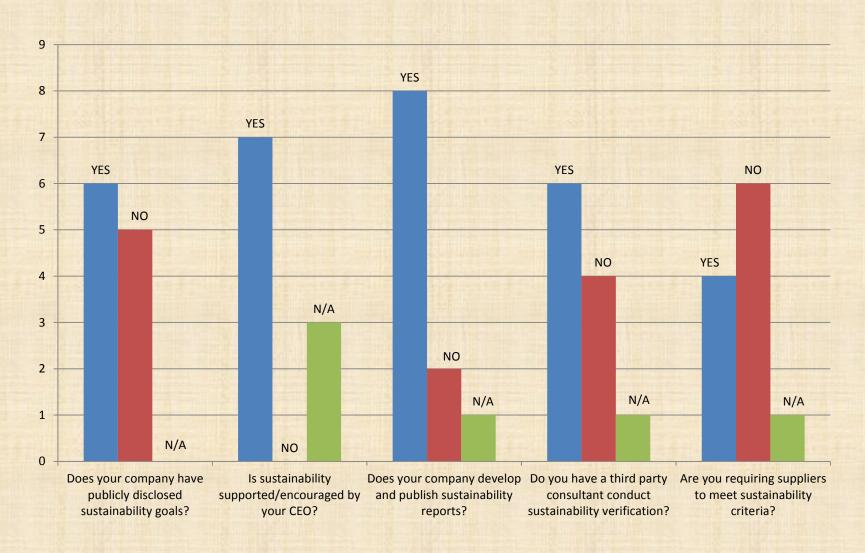
# If an employee is provided a doctors recommendation for an exercise ball as an "ADA Accommodation" how would your company respond?

- Requests are challenged
  - Should be limited to a fitness environment
  - Do not fall under legal definition of ADA
  - Request statement from physician explaining why available seating does not meet the employee's need.
- Final decision may be made external to EH&S
  - Human Resources / Job Accomodations



- Survey Monkey utilized to obtain data
- 42 EHSCP members surveyed
- Initial submittal 2/6/2014
  - 10 responses
- Re-submittal 3/18/2014
  - 2 additional responses received, 12 total
  - 28.6% response
- Data compiled 3/18/14
